



MEMORANDUM OF UNDERSTANDING

BETWEEN

UNIVERSITI SULTAN ZAINAL ABIDIN

AND

**SEKOLAH TINGGI AGAMA ISLAM NAHDLATUL
ULAMA PURWOREJO**

THIS MEMORANDUM OF UNDERSTANDING is made this of **19 March, 2023**;

BETWEEN

UNIVERSITI SULTAN ZAINAL ABIDIN (hereinafter referred to as "**UniSZA**"), a public university established under the Universities and University Colleges Act 1971 [*Act 30*] whose address is at Kampus Gong Badak, 21300 Kuala Nerus, Terengganu Darul Iman, Malaysia and shall include its lawful representatives and permitted assigns;

AND

SEKOLAH TINGGI AGAMA ISLAM NAHDLATUL ULAMA PURWOREJO (hereinafter referred to as "**STAINU**") a college established under the Imam Puro Purworejo Islamic Education Foundation whose address is at Jl. Pahlawan No.07, Rw. I, Kliwonan, Kec. Banyuurip, Kabupaten Purworejo, Jawa Tengah 54171, Indonesia and shall include its lawful representatives and permitted assigns;

UniSZA and STAINU hereinafter referred to individually as "**the Party**" and collectively as "**the Parties**".

WHEREAS

- A. UniSZA is an established public university which strives to enhance and strengthen its commitment to producing global leaders of tomorrow, and has taken various initiatives to complement its educational excellences. UniSZA has entered into various collaborative arrangements with other parties to enhance quality education and research.

- B. STAINU is the oldest Islamic Higher Education Institution in the Purworejo Regency and is among the oldest NU (Nahdlatul Ulama) Higher Education Institutions in Central Java. In its historical overview, STAINU Purworejo was established by ulama (Islamic scholars) and Nahdlatul Ulama intellectuals, as well as national Islamic movement figures, in response to the diverse needs of society at that time. On the 12th of Shafar, 1394 H, which corresponds to the 6th of March, 1974, an Islamic Higher Education Institution named PTII (Imam Puro Islamic Higher Education Institution) was founded under the Imam Puro Islamic Education Foundation (YPIL)

Purworejo. The establishment of PTII in Purworejo was preceded by the establishment of IAIN Sunan Kalijaga's Faculty of Pedagogy branch in Purworejo.

- C. The Parties are desirous of entering into this Memorandum of Understanding to declare their respective intentions and to establish a basis of co-operation and collaboration between the Parties on the terms as contained herein.

HEREBY REACHED AN UNDERSTANDING as follows:

ARTICLE I
OBJECTIVE

The Parties, subject to the terms of this Memorandum of Understanding and the laws, rules, regulations and national policies in force from time to time in their respective countries, will endeavour to strengthen, promote and develop co-operation between the Parties on the basis of equality and mutual benefit.

ARTICLE II
AREAS OF CO-OPERATION

1. Each Party will, subject to the laws, rules, regulations and national policies from time to time in force, governing the subject matter in their respective countries, endeavour to take necessary steps to encourage and promote co-operation in the following areas:
 - (a) Student and/or academic staff exchange;
 - (b) Academic exchange of professor on their sabbatical leave;
 - (c) Joint research activities;
 - (d) Exchange of publications, reports and other academic materials and information; and
 - (e) Any other areas of co-operation which may be mutually agreed upon by the Parties.

2. For the purpose of implementing the co-operation in respect of any areas stated in paragraph 1 the Parties may separately enter into a legally binding agreement subject

to terms and conditions as mutually agreed upon by the Parties including clauses on "confidentiality", "suspension", "protection of intellectual property rights" and "settlement of dispute".

ARTICLE III
FINANCIAL ARRANGEMENTS

1. This Memorandum of Understanding will not give rise to any financial obligation by one Party to other.
2. Each Party will bear its own cost and expenses in relation to this Memorandum of Understanding.

ARTICLE IV
EFFECT OF MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding serves only as a record of the Parties' intentions and does not constitute or create obligations under domestic or international law and will not give rise to any legal process and will not be deemed to constitute or create any legally binding or enforceable obligations, express or implied.

ARTICLE V
NO AGENCY

Nothing contained herein is to be construed so as to constitute a joint venture partnership or formal business organization of any kind between the Parties or so to constitute either Party as the agent of the other.

ARTICLE VI
ENTRY INTO EFFECT AND DURATION

1. This Memorandum of Understanding will come into effect on the date of signing and will remain in effect for a period of **FIVE (5)** years.
2. This Memorandum of Understanding may be extended for a further period as may be agreed in writing by the Parties.

ARTICLE VII

NOTICES

Any communication under this Memorandum of Understanding will be in writing in the English language and delivered by registered mail to the address or sent to the electronic mail address or facsimile number of UniSZA or STAINU as the case may be, shown below or to such other address or electronic mail address or facsimile number as either Party may have notified the sender and shall, unless otherwise provided herein, be deemed to be duly given or made when delivered to the recipient at such address or electronic mail address or facsimile number which is duly acknowledged:


